Lines 7 & 8 at 49th Ave are getting done with a few hick-ups. The pipe is across the street at 7 & 8. We tie in on line 7 east side and starting to dig on west side on Monday, July 2, 2018. The contractor hit our line going on line 8. It was not bad and Juan stayed late and got it fixed so we could keep irrigating on 7 & 8. We will connect line 8 on the week of July 16, 2018.

The homeowner's shade for his motorhome flew off and landed in our 39th Ave yard. The air vent was hit on the H.O.A. sea container; the H.O.A. was called and the homeowner replaced it with a new one. Everything is o.k.
