Discussion ensued between President Kay Lorenzen and Secretary Brett Harrison regarding the committee's recommendation and came to the conclusion that the new 2017-2018 proposed Operating Budget figures is as follows: Membership fee will increase \$1.77 for a total of \$42.85 per acre per month, the original Capital Expenditure fee of \$2.50 remains the same and the water rate will decrease \$.48 per hour for a total of \$25.44

per hour. These numbers were comprised from the budget information. Total water fee income \$267,120. Total membership income including Capital Expenditure fees \$450,598. Depreciation expense \$147,000.

<u>MOTION</u> Secretary Brett Harrison made a motion to approve the proposed Budget for 2017-2018 as recommended by the Budget Committee. The water fee is \$25.44 per hour, membership fee \$45.35 per acre per month which includes the \$2.50 capital expenditure fee per acre per month. President Kay Lorenzen seconded the motion. Motion Passed.
