#### A. Discuss and possible action to approve health insurance benefits:

# B. Discuss and possible action to award bid in reference to RFP 01-2015 "Office Building":

Discussion ensued between President Kay Lorenzen, Secretary Brett Harrison and Member Eldon Graber regarding the three (3) lowest bids and their qualifications. Discussion ensued regarding a puddle ramp, maintaining the parking lot and subcontractors. The three (3) lowest bids were as follows:

1. Kroll Construction	\$139,900.00
2. Distinctive Builders LLC	\$156.351.01
3. GCON	\$159,700.00

- <u>MOTION</u> President Kay Lorenzen made a motion to award the bid to Kroll Construction in the amount of \$139,900. Secretary Brett Harrison seconded the motion. Member Eldon Graber voted nay. Motion Passed.
  - C. Discuss and possible action to dissolve the New Office Building Committee:

<u>MOTION</u> President Kay Lorenzen *made a motion to dissolve the New Office Building Committee:* Secretary Brett Harrison seconded the motion. **Motion Passed,** unanimously.

# **D.** Discuss and possible action to approve an increase of membership fees to cover the cost of the District Building:

Discussion ensued regarding the committee's proposal and the additional cost of the New District Building which would increase the membership rate. The three (3) lowest increases range from \$4.72 to \$6.71 per acre per month.

<u>MOTION</u> Member Brett Harrison made a motion to increase the membership fee an additional \$4.72 per acre per month for one (1) year to pay the cost of the District Building. President Kay Lorenzen seconded the motion. Member Eldon Graber abstained. Motion Passed.

# E. Discuss and possible action to approve the proposed budget for FY 2015-2016 that's been recommended by the Budget Committee:

Discussion ensued between President Kay Lorenzen, Secretary Brett Harrison and Member Eldon Graber regarding the committee's recommendation and came to the conclusion that the new 2015-2016 proposed Annual Budget/Capital Budget figures is as follows: Membership fee will increase \$1.09 for a total of \$39.93 per acre per month and the original Capital Expenditure fee of \$2.50 remains the same and an additional \$4.72 per acre per month for one (1) year to cover the cost of the New District Building effective July 1, 2015. These numbers were comprised from the budget information. Total water fee income \$274,740. Total membership income including Capital Expenditure fees \$468,489. Depreciation expense \$117,960. Total general expenses \$412,831.

<u>MOTION</u> Brett Harrison made a motion to approve the proposed Budget for 2015-2016 as recommended by the Budget Committee. The water fee is \$28.92 per hour, membership fee \$47.15 per acre per month. President Kay Lorenzen seconded the motion. Motion Passed, unanimously.
