The employee evaluations committee is Larry Hudson, Peggy Schwend, and Karen England. The Irrigation District would like to thank these individuals for donating their time and input. Standing Water Problems if you have standing water (not soaking in within 72 hours) because of continuous use by horses, etc., it is recommended that you talk to the Irrigation Office for direction to some available services. The District is governed by State Statutes and by the Maricopa County Board of Supervisors. An elected three-member Board of Directors oversees all functions of the District. Board members are elected to a three-year term, staggered to allow one new member to be elected each November. See Attachment.
