1. CALL TO ORDER:

The meeting was called to order by President Karen Mills at 7:30 P.M.

2. APPROVAL OF MINUTES:

Barbara Campbell made a motion to approve the Regular Board of Directors Meeting on February 02, 2009. Markito Banuelos seconded the motion. Motion Passed, unanimously.

3. CORRESPONDENCE:

Secretary Barbara Campbell read the following correspondence. Letter dated February 05, 2009, February 28, 2009, February 05, 2009, March 01, 2009, and March 02, 2009 all correspondence from homeowner Randy Videen Lot #903 Line 03. See Attachments Correspondence submitted at February 03, 2009 Regular Board of Directors Meeting from homeowner Randy Videen Lot 903 Line 03 answered by Irrigation Manager Richard Mitten as follows:

- 1. Was the awning meant to help prevent rain water from entering the building? Yes.
- 2. What the cost of the project to date? Approximately \$800 material only.
- 3. What alternative remedies were suggested and what were the comparable costs and benefits? I can support records for three years this included a flood that occurred on August 3, 2005 Apex Carpet Cleaning with rental of three large fans in the amount of \$875. We've since purchased sand bags, graded, installation of cinder blocks and the use of gutters. Many employee hours had been spent pumping excess water out of the office. This does not include prior floods.
- 4. What was the cost of the permit for this structural project? No permit
- 5. What considerations were given to ADA compliance when building this structure? Westside entrance only.
- 6. Were there water delivery related projects which may have had a higher cost/benefit ratio? No

President Mills stated that this item will be on next months Agenda.

Barbara Campbell made a motion to approve the ad for 43rd Ave approximately 2,590 feet. Markito Banuelos seconded the motion. Motion Passed, unanimously.

J. Discuss and decide Lot 328 Line 10 "tree roots":

Tabled K. Discuss and decide Lot 496 Line 08 "tree uprooted":

Barbara Campbell made a motion to cut and remove fallen tree. Markito Banuelos seconded the motion. Discussion ensued on labor costs and dump fees. Policy states: "It's the homeowners' responsibility to manage and maintain their water once it arrives on the property;" and that "it's advisable to be present during the time of irrigation." With no further discussion President Mills called for the vote Markito Banuelos voted aye. President Karen Mills voted no. Barbara Campbell voted no. Markito Banuelos requested to change his vote to no. President Karen Mills stated by unanimous vote we have defeated the motion to cut up and remove the tree on Lot 496 Line 08.
