As you may be aware, Sunburst Farms Irrigation District has changed to the acreage system for polling and elections. This requires many property owners with the Irrigation District to follow some new requirements. Below is an extract from **A.R.S. Title 48 CH.19 48-3051.**

48-3051 B. Under the acreage system of voting, acreage standing in the name of a corporation, not exceeding one thousand two hundred eighty acres in all, may be voted an officer of the corporation designate by resolution of the Board of Directors of the corporation, adopted and filed with the secretary of the board at least thirty days previous to an election at which the acreage is to be voted.

48-3051 C. The general partner of a partnership in whose name title to property within the district is vested as a holder of title or evidence of title, who is designated and authorized in writing by all of the general partners, may register and cast the voted of the partnership

To become authorized and registered to vote for a corporation, general partnership or other organization, it is necessary to provide the Irrigation District with the following information:
